A RESOLUTION authorizing a three-month extension of the Agreement with Bruce Trammell of Lee's Summit, MO, to provide fiscal officer services for the use and benefit of the Jackson County Drug Task Force, at a cost to the County not to exceed \$3,460.80.

WHEREAS, by Resolution 17231, dated March 29, 2010, the Legislature did authorize the execution of an agreement with Bruce Trammell, of Lee's Summit, MO for fiscal services for the Jackson County Drug Task Force (JCDTF) for a period of one year, at a cost to the County not to exceed \$15,000.00; and,

WHEREAS, because Mr. Trammell's relationship with the JCDTF is more consistent with the IRS definition of an employee, he will be converted from an independent contractor to a part-time employee with the County, beginning April 1, 2011; and,

WHEREAS, an extension to the existing Agreement is necessary to cover the costs of Mr. Trammell's services from January 1, 2011, through March 31, 2011; and,

WHEREAS, this extension is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,
