WHEREAS, by Resolution 14386, dated November 25, 2002, the Legislature authorized twelve-month term and supply contracts with Controlled Environmental Products (CEP) of Kansas City, MO, Ecolab, Inc., of St. Paul, MN, and All American Poly of Piscataway, NJ, for the furnishing of janitorial supplies for use by various County departments in the estimated aggregate amount of \$145,000.00; and,

WHEREAS, as authorized by the contract, the Director of Purchasing extended the contracts for an additional one year period from December 3, 2003 to December 2, 2004; and,

WHEREAS, the Director of Purchasing recommends an increase to the contract with Controlled Environmental Products (CEP) of Kansas City, MO, in the estimated annual amount of \$61,277.25, for a revised estimate aggregate total not to exceed \$206,277.25 for the contract period beginning
