IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a contract on Bid No. 32-01 for the furnishing of one turf tractor and four utility vehicles, for use by the Parks and Recreation Department to Lawn and Leisure of Lee's Summit, MO (\$13,495.00), and Turf Professionals Equipment Company of Lenexa, KS (\$19,996.00), in the actual aggregate amount of \$33,491.00, and declaring certain personal property as surplus and authorizing its disposal by way of trade-in.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 32-01 for the furnishing of one turf tractor and four utility vehicles for use by the Parks and Recreation Department; and.
