A RESOLUTION authorizing the County Executive to execute a cooperative agreement with Della Lamb Community Services for its youth after school programs at a cost to the County of \$46,666.66, as a local grant match.

WHEREAS, the Della Lamb Community Services youth after school programs target low income youth, ages five to fourteen, and prevents crime, drug usage and abuse by offering positive after school programming structured through educational and recreational opportunities including tutoring, teen clubs, aerobics, and music; and,

WHEREAS, the youth after school program is funded by a grant awarded by the Local Investment Commission (LINC), in the amount of \$187,467.00; and,

WHEREAS, these funds are subject to a local match in the aggregate amount of \$46,666.66 for 2006 and 2007; and

WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure of these funds; therefore,
