AN ORDINANCE appropriating \$47,103.00 from the fund balance of the 2009 Anti-Drug Sales Tax Fund to cover a grant received by the Sheriff's Office from the United States Executive Office of the President's Midwest High Intensity Drug Trafficking Area Investigative Support Center to be used to retain an intelligence analyst.

WHEREAS, the United States Executive Office of the President's Midwest High Intensity Drug Trafficking Area (HIDTA) Investigative Support Center has allocated a total of \$47,103.00 for fiscal years 2008-2009 for an intelligence analyst to be retained on contract for use by the Jackson County Sheriff's Office; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,
