Anti-Drug Committee Amendment June 12, 2006

IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$167,000.00 from the unappropriated surplus of the 2006 Anti-Drug Sales Tax Fund and authorizing the County Executive to execute a cooperative agreement with Swope Health Services in the amount of \$392,000.00 to provide substance abuse treatment and mental health services to clients of the Jackson County Mental Health Court.

WHEREAS, Swope Health Services has submitted a proposal for funding for 2005-2006 from the Anti-Drug Sales Tax Fund to provide comprehensive substance abuse treatment and mental health services to clients of the Jackson County Mental Health Court, in the amount of \$407,000.00; and,

WHEREAS, funding of this proposal is in the best interests of the health, welfare and safety of the citizens of Jackson County; and,
