### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing payment of \$12,032.76 to the City of Greenwood from the Greenwood CURS account to cover maintenance costs for the City's 2000 street and road maintenance program.

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that pursuant to Chapter 28, Jackson County Code, 1984, the Director of the Department of Finance is authorized to issue a check in the amount of \$12,032.76 to the City of Greenwood for use in the City's 2000 street and road maintenance program.
