IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$57,580.00 from the unappropriated surplus of the 1995 County Urban Road System Fund and authorizing the Director of Public Works to execute an Agreement with Kansas City Southern Railroad Company in connection with the Longview Road at Blue Ridge Project No. 2075-3, at a cost to the County not to exceed \$57,580.00.

ORDINANCE #2434, July 24, 1995

WHEREAS, the construction of Longview Road at Blue Ridge, Project 2075-3, requires a new railroad bridge be constructed within the area from Applewood to Blue Ridge; and,

WHEREAS, a shoofly must be constructed to reroute railroad traffic during the construction of the bridge; and,

WHEREAS, pursuant to the attached Agreement, the Kansas City Southern Railroad Co. and the County will cooperate in the necessary construction; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the 1995 County Urban Road System Fund:
