A RESOLUTION awarding a term and supply contract on Bid No.155-97 for the furnishing of janitorial supplies for use by various County departments to Riteway Magic Supply of Grandview, MO (\$50,000.00), Perfection Industrial of Kansas City, MO (\$30,000.00), and Pur-O-Zone, Inc., of Lawrence, KS (\$30,000.00), to provide for countywide needs for the upcoming one-year period, in the estimated aggregate amount of \$110,000.00.

WHEREAS, award as recommended would result in estimated awards to the following vendors:
