WHEREAS, pursuant to section 9140., <u>Jackson County Code</u>, 1984, the Legislature may authorize a contract with one or more qualified experts to advise the Board of Equalization; and,

WHEREAS, pursuant to section 9141., <u>Jackson County Code</u>, 1984, the Legislative Auditor prepared Request for Proposal 14-08 and distributed same to potential interested parties; and,

WHEREAS, by Resolution 16662, dated June 16, 2008, the Legislature did authorize the execution of an agreement with Abstract Appraisals of Kansas City, MO, at a cost not to exceed \$7,500.00; and,

WHEREAS, pursuant to the terms of Request for Proposal 14-08 the Director of Finance and Purchasing now requests authorization to extend the contract for twelve (12) months, with an additional twenty-four (24) month extension option; now therefore,
