**AN ORDINANCE** appropriating \$1,000,000.00 from the unappropriated surplus of the 2003 Public Building Corporation Capital Projects Fund and authorizing the Purchasing Director to execute a Real Estate Sales Contract and any other documents necessary to effect the purchase of the property located at 303 West Walnut in Independence, Missouri, from The Arthur N. Nystrom Trust/Patricia Nystrom Trust, for use as a Public Works Administration/Tech Center, at the actual cost to the County of \$560,000.00.

WHEREAS, the Purchasing Director recommends the purchase of the property located at 303 West Walnut in Independence, Missouri, from the Arthur N. Nystrom Trust/Patricia Nystrom Trust, for use as a Public Works Administration/Tech Center, at the actual cost to the County of \$560,000; and,

WHEREAS, in order to fund this purchase, an appropriation of a portion of the proceeds of the 2003 leasehold revenue bond issue authorized by Ordinance 3420, dated September 22, 2003, is necessary; and,

WHEREAS, the funds appropriated by this Ordinance not needed for the purchase of the property will be used for its renovation and improvement; now therefore,
