## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$21,000.00 from the undesignated fund balance of the 2014 Federal Forfeiture Fund and awarding a contract for the furnishing of four 2012 Dodge Charger police vehicles to the Missouri State Highway Patrol, at an actual cost to the County of \$63,000.00, as an acquisition from another government.

WHEREAS, the Sheriff's Office desires to purchase four 2012 Dodge Chargers from the Missouri Highway Patrol to add to its fleet of emergency vehicles; and,

WHEREAS, pursuant to section 1030.2 <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends award of a contract to the Missouri State Highway Patrol for the furnishing of the fleet vehicles, as an acquisition from another government, at an actual cost to the County of \$63,000.00; and,

WHEREAS, the Sheriff's Office desires to use Federal Forfeiture Funds to partially fund the costs of these vehicles; and,

WHEREAS, an appropriation is necessary to place funds available in the Federal Forfeiture Fund in the proper spending account; now therefore,
