## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$6,614.00 from the unappropriated surplus of the 2000 Special Road and Bridge Fund and authorizing Change Order No. 1 to the contract with Meadows Construction Company of Tonganoxie, KS, for the Buckner-Tarsney Road Bridge Replacement and Sni-A-Bar Blvd. Detour, Project No. 2264, increasing the contract amount by \$6,614.00.

**ORDINANCE #3031**, July 10, 2000

**INTRODUCED BY** Bill Petrie, County Legislator

WHEREAS, the County did, by Ordinance 3001, dated March 6, 2000, enter into a contract with Meadows Construction Company of Tonganoxie, KS, in the amount of \$2,051,883.32, for the Buckner-Tarsney Road Bridge Replacement and Sni-A-Bar Blvd. Detour; and,

WHEREAS, the proposed Change Order No. 1, a copy of which is attached hereto and incorporated herein by reference, is necessary as SWG Investments which, will be developing the adjacent property, desires to upsize some of the stormwater sewers, and has agreed to pay for the upsizing in the amount of \$6,614.00, thereby increasing the contract in an amount not to exceed \$6,614.00; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the unappropriated surplus of the 2000 Special Road and Bridge Fund be and here is made:
