**A RESOLUTION** transferring \$20,000.00 within the 2011 Anti-Drug Sales Tax Fund for anti-drug prevention programs and services to be provided by the Jackson County Family Court.

WHEREAS, the Drug Commission now recommends that the remaining balance of \$20,000.00 allocated to the Family Court anti-drug program be transferred; and,

WHEREAS, the County Executive recommends this transfer; and,
