IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a term and supply contract on Bid No. 81-98 for the furnishing of park ranger uniforms for use by the Parks and Recreation Department to Jay's Uniforms of Shawnee Mission, KS (\$19,335.20), Tuxall Uniform & Equipment of Kansas City, MO (\$9,792.50), Ray O'Herron Company of Danville, IL (\$705.00), Law Enforcement Equipment Co. of Kansas City, MO (\$578.05), and Western Army Store of Independence, MO (\$1,116.00), to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$31,526.75.
