WHEREAS, the Prosecuting Attorney has recommended Anti-Drug Sales Tax funds in the amount of \$5,000.00 for the prevention of drug and drug-related offenses; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a Cooperative Agreement, in a form to be approved by the County Counselor, with the Calvary Community Outreach Network, at a cost to the County not to exceed \$5,000.00; and,
