IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE transferring \$92,488.00 as matching funds and appropriating \$190,928.00 from the unappropriated surplus of the 2005 Grant Fund to accept a grant from the Missouri Department of Public Safety for a program focused on prevention and prosecution of sexual assaults.

ORDINANCE # 3625, April 12, 2005

WHEREAS, Jackson County has been awarded \$98,440.00 by the Missouri Department of Public Safety for the partial funding of three (3) full-time prosecutors for a project with a total cost of \$190,928.00 and which requires matching funds of \$92,488.00; and,

WHEREAS, this grant is to prevent and prosecute sexual assaults in the County; and,

WHEREAS, the grant term is from January 1, 2005 through December 31, 2005; and,

WHEREAS, a transfer and appropriation are necessary in order to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer
