WHEREAS, the Public Administrator's Office has a continuing need for annual maintenance and support of its proprietary SEM Applications software; and,

WHEREAS, the Office currently uses SEM Applications' accounting software to maintain financial records for its managed estates; and,

WHEREAS, the required maintenance agreement supports this critical application necessary for the County business; and,

WHEREAS, annual software maintenance agreements are considered sole source purchases, as the maintenance can only be provided by the software's developer; and,

WHEREAS, pursuant to section 1030.1 of the <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends the award of a software maintenance and support agreement for use

payments, including final payment, on the contract.
