A RESOLUTION authorizing the County Executive to execute an easement in favor of the Tarsney Lakes Citizens Association, Inc., a Missouri Non-Profit Corporation, affecting County road right-of-way within the Tarsney Lakes subdivision.

INTRODUCED BY Bob Spence, County Legislators

WHEREAS, the Tarsney Lakes Citizens Association, Inc., a Missouri Non-Profit Corporation has requested an easement from the County to facilitate the construction and maintenance of a water line to a fire hydrant on the following described tract of land:

Part of Lot 7, Block 26, Tarsney Lakes, a subdivision in Jackson County, Missouri, described as follows:

A strip of land 25.00 feet in width lying 12.50 feet on each side of the following described centerline. Commencing at the northwest corner lot 2, Block 23 of said subdivision thence North 10 degrees, 11 minutes West, 119.40 feet to a point on the east line of said Lot 7, Block 26, said point also being the true point of beginning of the centerline of said 25.00 foot wide strip of land; thence North 77 degrees, 56 minutes West, 75.00 feet to a point of termination. (The North line of said Lot 2, Block 23 is assumed to bear North 89 degrees West).

WHEREAS, the aforementioned easement, is necessary in order to run the water line to a fire hydrant and there is no practical way to avoid the use of County road right-of-way; and,
