BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached right-of-way, be and hereby is accepted and that the Director of the Department of Finance and Purchasing be and hereby is directed to issue a lump sum payment in the amount of \$6,470.00 to William W. Bowlin in consideration for said right-of-way, pursuant to the specific direction of the Director of Public Works.
