IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a contract for the furnishing of officiating services for the 1999-2000 Jackson County Soccer Leagues for use by the Parks and Recreation Department to Metropolitan Soccer Referee Association of Kansas City, MO, at a cost to the County not to exceed \$73,000,00, as a sole source purchase. RESOLUTION #12551, February 22, 1999

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Metropolitan Soccer Referee Association of Kansas City, MO, for the furnishing of officiating services for the 1999-2000 Jackson County Soccer Leagues for use by the Parks and Recreation Department; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that Metropolitan Soccer Referee Association of Kansas City, MO, is the only supplier of soccer officiating services in the Kansas City metropolitan area meeting the necessary requirements; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Purchasing Director be, and hereby is, authorized to execute for the County a contract with Metropolitan Soccer Referee Association of Kansas City, MO, for the furnishing of officiating services for the 1999-2000 Jackson County Soccer Leagues for the Parks and Recreation Department, in an amount not to exceed \$73,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments including final payment on the contract thereby made...Attorney
