IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a contract for the purchase of lighting equipment for use by the Parks and Recreation Department to Musco Sports Lighting Co. of Muscatine, IA, at a cost to the County not to exceed \$135,500.00, as a sole source purchase.

RESOLUTION #12117, March 16, 1998

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Musco Sports Lighting Co. of Muscatine, IA, for the purchase of lighting equipment for use by the Parks and Recreation Department; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that Musco Sports Lighting Co. of Muscatine, IA, is the only known supplier of the lighting equipment needed; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
