A RESOLUTION awarding a term and supply contract on Bid No. 74-95 for the furnishing of mattresses, bedding, and linens for use to by the Department of Corrections to Tabb Textile of Opelika, AL, Robinson Textiles of Gardena, CA, American Overseas International of Indio, CA, Chestnut Ridge of N. Latrobe, PA, Textile Sales of Baltimore, MD, and American Institutional Supply of W. Trenton, NJ, to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$49,205.75.

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards to the following vendors:
