IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE setting the 2002 Jackson County, Missouri tentative tax levy.

ORDINANCE #3209, November 13, 2001

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, Section 539.00 of the Jackson County Code requires the County Legislature to adopt a tentative tax levy sufficient to provide for appropriations in the county budget; and,

WHEREAS, the 2002 annual county budget would require the following tax levies on each hundred dollars of assessed valuation for the fiscal year 2002:

WHEREAS, pursuant to authorization granted by Sections 67.500 through .545, RSMo, the qualified voters in Jackson County on November 6, 1979, approved Jackson County Proposition #1 which imposed a county-wide sales tax on one-half of one percent and required that the total county property tax levy be reduced by 70% of the total amount of the sales tax revenues in the tax year; and,

WHEREAS, Section 67.505, RSMo, requires that after the County has determined its budget, the total property tax levy must be reduced in an amount sufficient to decrease the total property taxes it will collect by an amount equal to 70% of the sales tax revenue in the same tax year; and,

WHEREAS, the tentative estimate of the sales tax revenues to be collected in 2002 is \$38,307,964.00; and,
