WHEREAS, the Jackson County Legislature desires to hold a closed meeting on Tuesday, September 5, 2017, during the regularly scheduled meeting of the Legislature; and,

WHEREAS, public notice of such closed meeting has been given by inclusion of this Resolution on the published agenda for said meeting; and,

WHEREAS, the purpose of such closed meeting is to conduct confidential communications concerning existing and/or proposed security systems and structural plans of real property owned by Jackson County, the disclosure of which would threaten public safety; and,

WHEREAS, the disclosure of this information, including records to be discussed at said meeting, would impair the Legislature's ability to protect the security and/or safety of persons and/or real property, such that the public interest in nondisclosure outweighs the public interest in disclosure of
