IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a term and supply contract on Bid No. 194-98 for the furnishing of miscellaneous PC hardware and software for use county-wide to Midwest Technology of Kansas City, MO (\$15,000.00), Azarat Marketing of Miami, FL (\$9,000.00), Micrologic Business of Independence, MO (\$6,000.00), Dot Com of Union City, CA (\$5,000.00), Resellers Corporation of Lomita, CA (\$5,000.00), Vertex Technologies of Momouth Junction, NJ (\$3,000.00), Nasatech of Overland Park, KS (\$3,000.00), Missouri Information of Kansas City, MO (\$2,500.00), American Datacom of Overland Park, KS (\$1,500.00), and Arsys Innotech of Fremont, CA (\$1,500.00), to provide for county-wide needs for the upcoming one-year period, in the estimated aggregate amount of \$51,500.00.
