BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriation to the using spending agency has heretofore been made in the current Jackson County budget. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
