A RESOLUTION awarding a term-and-supply contract on Bid No. 27-01 for the furnishing of T-shirts and wearing apparel for use by various departments to Raytown Screen Printing of Raytown, MO (\$40,308.15), Executive Marketing Promotions of Kansas City, MO (\$18,743.00), and Game Time Graphics of Independence, MO (\$6,557.00), to provide for their needs for the upcoming one-year period, in the estimated aggregate amount of \$65,608.15.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 27-01 for the furnishing of T-shirts and wearing apparel for use by various departments; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards for the respective vendors as follows:
