IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION transferring \$26,682.00 within the 2015 Anti-Drug Sales Tax Fund to provide matching funds for the Prosecuting Attorney's Office's Victim Services Program.

RESOLUTION NO. 18877, July 6, 2015

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, by Ordinance 4560, dated September 9, 2013, the Legislature did authorize the acceptance of a grant from the Missouri Department of Public Safety for the Prosecuting Attorney's Office's Victim Services Program, for the period July 1, 2013, through June 30, 2015; and,

WHEREAS, this two-year grant covers partial funding for the salary, benefits, and training costs for two victim advocates and requires additional matching funds in the amount of \$26,681.96 for the final year of the grant; and,

WHEREAS, a transfer is necessary in order to place the matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer
