AN ORDINANCE appropriating \$53,875.00 from the unappropriated surplus of the 2006 Grant Fund in acceptance of a grant awarded to the Family Court Division by the Missouri Department of Public Safety for the Victim Advocacy Program.

ORDINANCE # 3800, August 21, 2006

WHEREAS, the Missouri Department of Public Safety has awarded a grant in the amount of \$53,875.00 to the Family Court Division of the Circuit Court of Jackson County, Missouri for its Victim Advocacy Program; and,

WHEREAS, the Victim Advocacy Program provides services to children and their non-offending family members seen at the Child Protection Center, a project of Jackson County Family Court Services; and,

WHEREAS, comprehensive services for the Victim Advocacy program will include crisis intervention, follow-up, referral, and linkage to therapy and other needed community services, and support and advocacy throughout the investigation and any medical or court proceedings; and,

WHEREAS, the term of this grant is from July 1, 2006, through June 30, 2007; and,
