IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute an Agreement with the Kansas City Keys Community Council, for its Keys and Pizza Hut program, in an amount not to exceed \$20,000.00, as a local match to a private grant.

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the Kansas City Keys Community Council's "Keys and Pizza Hut" program is designed to improve academic achievement through life skills training to assist in better choices, by providing a core educational curriculum, and by promoting substance abuse awareness; and,

WHEREAS, the Kansas City Keys Community Council has received a grant from Pizza Hut of Kansas City for this program, in the amount of \$20,000.00; and,

WHEREAS, this grant is subject to a local match in the amount of \$20,000.00; and,

WHEREAS, the Kansas City Keys Community Council has requested anti-drug sales tax funds in the amount of \$20,000.00 to provide the required local match for this program; and,

WHEREAS, the Prosecuting Attorney has reviewed this request and recommends funding in the amount of \$20,000.00 from his grant match account; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute the attached Agreement with the Kansas City Keys Community Council; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is hereby authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
