Anti-Drug Committee Amendment February 17, 2009

IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute agreements with certain outside agencies which engage in anti-drug related activities, to provide a local match to federal, state, local and/or private grant funds, at an aggregate cost to the County not to exceed \$1,026,082.44.

WHEREAS, the execution of agreements for the services of these agencies, in the amounts indicated on Exhibit A, is in the best interest of the health, welfare and safety of the citizens of Jackson County; now therefore,
