A RESOLUTION transferring \$20,000.00 within the 2011 Anti-Drug Sales Tax Fund for anti-drug prevention programs and services to be provided by the Family Court.

RESOLUTION #17475, January 24, 2011

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the voters of Jackson County, Missouri, renewed the sales tax for seven years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the proceeds and interest generated from this tax are deposited in a special Jackson County Anti-Drug Sales Tax Trust Fund that is segregated and not commingled with the general fund or any other special funds of the County; and,

WHEREAS, the Drug Commission has recommended providing funds to the Jackson County Family Court for anti-drug prevention activities and purposes; and,

WHEREAS, an inter-departmental transfer is necessary to place these funds into the proper spending account; and,

WHEREAS, the County Executive recommends this transfer; and,
