A RESOLUTION awarding a term-and-supply contract on Bid No. 21-02 for the furnishing of concessions chips and snacks for use by the Parks and Recreation Department to Lady Baltimore of Kansas City, KS (\$10,000.00), Frito-Lay of Kansas City, MO (\$25,000.00), and Wisconsin Bar Brand of Olathe, KS (\$5,000.00), to provide for departmental needs for the upcoming one-year period, in the estimated aggregate amount of \$40,000.00.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No.21-02 for the furnishing of concessions chips and snacks for use by the Parks and Recreation Department; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to three different vendors to ensure low pricing, and the availability of a wide variety of products in the needed quantities; and,

WHEREAS, award as recommended would result in the estimated awards for the respective vendors as follows:
