IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$100,500.00 from the fund balance of the 2008 Grant Fund in acceptance of the Family Court Division's Family Centered Out-of-Home Care Grant received from the Missouri Department of Social Services, Children's Division.

ORDINANCE #4037, September 29, 2008

WHEREAS, the Family Court Division has been awarded a grant in the amount of \$100,500.00 by the Missouri Department of Social Services, Children's Division for the period of July 1, 2008, through June 30, 2009; and,

WHEREAS, the grant funds will be used to provide for immediate involvement of a juvenile officer in all potential and real out-of-home placements to expedite permanency for children who come to the attention of the child welfare system; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the fund balance of the 2008 Grant Fund:
