WHEREAS, the Director of Purchasing, pursuant to Section 1040.04 of the <u>Jackson County Code</u>, 1984, recommends the award of a contract for the furnishing of Dell Computers for use by the Family Support Division of the Prosecuting Attorney's office to Dell Marketing L.P. of Austin, TX, in the actual amount of \$13,390.00, under an existing government contract of the State of New Mexico; and,

WHEREAS, Section 1064.00, <u>Jackson County Code</u>, 1984, requires that, for any such award in excess of \$5,000, the Director of Purchasing shall submit the award to the County Legislature for approval; and,

BE IT FURTHER RESOLVED that award be made as recommended by the Purchasing Director and that the Purchasing Director be and hereby is authorized to execute any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract thereby made.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
