WHEREAS, Truman Medical Center Behavioral Health Services, a division of Truman Medical Center, Inc., has submitted a proposal for funding in 2004 from the Anti-Drug Sales Tax Fund for a substance abuse treatment program providing comprehensive substance abuse treatment services to inmates of the Jackson County Detention Center, in the amount of \$281,205.00; and,

WHEREAS, this proposal includes an option on the part of the County to renew the contract for 2005, at an agreed-upon rate; and,

WHEREAS, the Director of Corrections has reviewed the proposal submitted by Truman Medical Center Behavioral Health Services and recommends funding in 2004; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into the attached Agreement with Truman Medical Center Behavioral Health Services; and,
