WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 190-98 for the furnishing of custom file folders and dividers for use by the Prosecuting Attorney's Office to provide for departmental needs for the upcoming one-year period; and,

WHEREAS, the only bids meeting specifications were received from Midwest Power Files of Kansas City, KS, and Retrieval Business Systems of Milan, IL; and,

WHEREAS, the Purchasing Director has recommended that award be made to Midwest Power Files of Kansas City, KS, for the reason that it has submitted the lowest and best bid as set forth in the attached recapitulation and analysis; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget. Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
