## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$100,000.00 from the fund balance of the 2008 Anti-Drug Sales Tax Fund and authorizing the County Executive to execute an addendum to the contract with Truman Medical Center Behavioral Health for outpatient anti-drug treatment services, at a cost to the County not to exceed \$100,000.00.

**ORDINANCE #4077**, December 12, 2008

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, by Resolution 16492, dated January 7, 2008, the County Legislature did authorize the execution of agreements with outside agencies for anti-drug treatment activities and purposes, which included Truman Medical Center Behavioral Health; and,

WHEREAS, Truman Medical Center Behavioral Health has delivered outpatient treatment services in 2008, exceeding the original contracted amount by \$130,000.00, and has requested additional funding in the amount of \$100,000.00; and,

WHEREAS, an appropriation is necessary to cover these costs; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following
