A RESOLUTION designating the week of April 18-24, 1999, as National County Government Week in Jackson County, Missouri.

WHEREAS, Jackson County's primary concern is to assure that its citizens and their families live in a community that is safe, strong, and rich in culture; and,

WHEREAS, the National Association of Counties has designated the week of April 18 - 24, 1999 as "National County Government Week" with a theme of "Counties Celebrate the Arts"; and,

WHEREAS, as part of its celebration, Jackson County will sponsor a Free Sidewalk Art Event for Kids at the City Market, Saturday April 24th, starting at 8 a.m.; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature hereby designates the week of April 18-24, 1999, as National County Government Week in Jackson County, Missouri.
