IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI
A RESOLUTION awarding a contract on Bid No. 126-97 for the sale of surplus animal stock to R. Duane Rogers of Pleasant Hill, MO, Winrock Elk & Bison of Overland Park, KS, and Burditt Elk Ranch of Monroe City, MO, in the actual aggregate amount of \$20,648.00.

RESOLUTION #11904, October 6, 1997

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 126-97 for the sale of two bison bull calves, four bison heifer calves, two elk bull calves, and three elk heifer calves, which are surplus to the County; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the sale award of the surplus animal stock, be divided and awarded to the bidder submitting the highest bid for each animal; and,

WHEREAS, award as recommended would result in the aggregate amounts for the respective bidders as follows:

#1 (2) Bison Bulls	R. Duane Rogers Pleasant Hill, M	\$1,300.00
#2 (4) Bison Heifers	Windrock Elk & Bison Overland Park, KS	\$5,604.00
#3 (2) Elk Bulls	Burditt Elk Ranch Monroe City, MO	\$2,032.00
#4 (3) Elk Heifer	Burditt Elk Ranch Monroe City, MO	\$11,712.00

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award...Attorney
