WHEREAS, pursuant to section 1054.6, <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends the award of a contract to Resource Development Institute of Kansas City, MO, because of their experience, references, and firm capability; and,

WHEREAS, section 9058, <u>Jackson County Code</u>, 1984, provides that subject to the approval of the Legislature any contracts for these purposes are to be executed by the County Executive; now
