BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award of Bid No. 61-04 be made as recommended by the Purchasing Director to Guier Fence of Blue Springs, MO, in the actual amount to the County not to exceed \$10,647.00, and that the County Executive and Purchasing Director be, and are hereby, authorized to execute for the County any documents necessary to the accomplishment of the award.
