ORDINANCE #3584 , November 29, 2004

INTRODUCED BY Robert A. Stringfield and Scott Burnett, County Legislators

WHEREAS, the County has been awarded a grant in the amount of \$25,000 by the Missouri

Department of Transportation-Office of Highway Safety for its Sobriety Checkpoint program; and,

WHEREAS, Jackson County ranks 1st in the State of Missouri in alcohol related crashes; and,

WHEREAS, this grant will fund reimbursement of overtime used for setting up sobriety checkpoints and other alcohol related activities and allows for the purchase of one sobriety checkpoint equipment trailer; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made;
