RESOLUTION # 15284, November 29, 2004

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, Section 1040.4 of the Jackson County Code, 1984, eliminates the requirement for

competitive bidding when items to be purchased can be obtained through an existing fixed price contract and agreement of a federal, state or local government where it is to the County's advantage to buy under that agreement; and,

WHEREAS, Section 1064.00 of the Code requires notification of and approval by the Legislature on purchases exceeding \$5,000.00 under an existing government contract and a transfer of funds is required to enable this purchase; and,

WHEREAS, the Purchasing Director recommends that the County purchase a Model Year 2005 Ford Econoline Club Wagon 15 Passenger Window Van for use by the Parks & Recreation Department under an existing government contract through the Mid-America Council of Public Purchasing (MACPP) Cooperative Fleet Bid from Shawnee Mission Ford of Shawnee, KS at an actual cost to the County in the amount of \$19,616.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase of a Model Year 2005 Ford Econoline Club Wagon 15 Passenger Window Van for use by the Parks & Recreation Department under an existing government contract through the Mid-America Council of Public Purchasing (MACPP) Cooperative Fleet Bid from Shawnee Mission Ford of Shawnee, KS in the actual amount of \$19,616.00 be made as recommended under the existing government contract by the Purchasing Director in the total amount not to exceed \$19,616.00, and that the Purchasing Director be, and is hereby, authorized to execute any documents required to enable the purchase as recommended by the Purchasing Director; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract thereby made.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
