WHEREAS, upon past history of performance by Biggs Pest Control and a reference check with Kansas City, MO of the performance of Lawrence Pest Control, the Purchasing Director has recommended that the award be made to Ragan Pest Control of Kansas City, MO, for the reason that it has submitted the lowest and best bid; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award for the furnishing of pest control services for use by the Facilities Management Department be made to Ragan Pest Control of Kansas City, MO, in the estimated amount not to exceed \$10,000.00 as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,
