WHEREAS, the Director of the Department of Public Works recommends acceptance of the right-ofway and easements upon the specified terms; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached right-of-way and easements, be and hereby are accepted and that the Director of Finance and Purchasing be and hereby is directed to issue a lump sum payment in the amount of \$223,845.00 to Property Reserve, Inc., in consideration for said right-of-way and easements, pursuant to the specific direction of the Director of the Department of Public Works; and,

BE IT FURTHER RESOLVED that the County Executive be and hereby is authorized to execute any and all other documents necessary to the accomplishment of this transaction.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
