WHEREAS, the Constructing Futures Project is a unique public-private partnership designed to provide a structured pathway to allow former drug offenders to enter the construction industry, and at the same time provide transitional and permanent housing to those in need; and,

WHEREAS, the project will allow recovering drug offenders to learn the construction trade by rehabilitating an abandoned house that can then be occupied by a homeless family; and,

BE IT FURTHER RESOLVED, that the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a Cooperative Agreement, in a form to be approved by the County Counselor, with Connections to Success, Inc., at a cost to the County not to exceed \$75,000.00; and,

BE IT FURTHER RESOLVED, that the Director of Finance and Purchasing be and hereby is authorized to make all payments including final payment on the agreement.
