WHEREAS, the Director of Finance and Purchasing has solicited bids on Electronic Solicitation No.

BB201015 for the furnishing of marine supplies and accessories for resale at county marinas by the Parks and Recreation to provide for departmental needs for the upcoming twenty-four (24) month period, with options to extend for twelve (12) month terms not to exceed an additional total of twenty-four (24) months; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contracts and subsequent extensions, to the extent that sufficient appropriations to the using spending agencies have been made in the then current Jackson County budget.
