cost to the County not to exceed \$6,800.00, as a sole source purchase; and,

be and hereby is authorized to execute an addendum to the contract with Mitchell Humphrey and							
Company of St. Louis, MO, and any and all other documents necessary to the accomplishment of the							
award, in forms to be approved by the County Counselor; and,							
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the contract and addendum thereto.
